AIDSCARE Inc. is the sponsor of The Phoenix House, L.L.C., a new three story Sobriety Supportive Housing Program for individuals, who are homeless, disabled and have HIV/AIDS at 1251 South Sawyer in the North Lawndale neighborhood in Chicago. There are a total of 32 Studio units with private bathroom and kitchenette. Also in the building are community rooms and laundry facilities. Residents pay 30% of their **adjusted gross income each month to live at The Phoenix. Potential residents must** have income at or below 50% of the Chicago area median income to qualify for this housing. The acceptable maximum income levels per this formula are \$26,400 for a one person household. Households at The Phoenix House, L.L.C. may not exceed 1 person for a studio unit.

The Phoenix House is a Sobriety Supportive Housing Program. Residents agree to not use alcohol or illegal drugs while living at the Phoenix. Supportive services will be provided by onsite social service personnel.

We offer equal housing opportunities to all applicants regardless of race, religion, color, sex, sexual orientation, national origin, disability or family status, except that the applicant must be homeless, disabled, have HIV/AIDS and be 21 years or older. The applicant must meet all other requirements of The Phoenix, L.L.C.

Potential residents may be eligible for a preference. Individuals qualifying for a preference will receive assistance before any other applicants that are not so qualified. The following condition qualifies a pre-applicant for a preference; 1.) Pre-applicants who have HIV/AIDS and have a homeless status. For individuals not claiming the housing preference, screening will be conducted according to the order in which the pre-applications were received.

We will accept the pre-applications ONLY b y U.S. mail. Additional application information will be requested prior to occupancy. Occupancy is expected to begin in February 2008.
